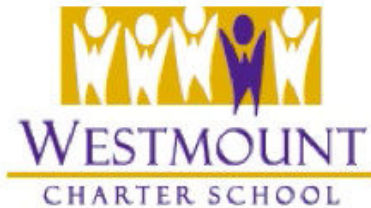

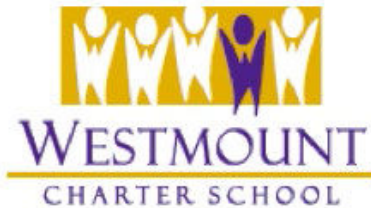
4. **Community Update** | Simon C.
