3. School Council Reports

a. Fundraising Events | Laura T.

Huge thank you to family members who helped with fundraising for the year. First set of fundraising initiatives were the Stampeder Parking events (nine events held, raising about \$5000). Purdy's holiday fundraiser at Elementary Campus



raised about \$1000. In February the in-person bottle drive raised about \$700 (additional funds were raised throughout the year with the Skip the Depot program). Healthy Hunger lunches (appx. 20 deliveries between the two campuses) raised about \$5000. Finally, the 50/50 and WestJet raffle fundraisers were a success (winners will be drawn at the end of the meeting).

- b. **Treasury** | Navdeep K.
 - Roti shared the interim report that Navdeep provided.
 - Banking transactions continue until August 31st, followed by project discussions with the Principals, School Council and Treasurer. Allocations are made and budget will be reviewed, discussed and approved in October 2024.
 - Invoices are just under \$10K against a budget of \$40K.
 - Year to date revenue is just over \$12K against the \$13K budgeted.
- c. Parent Engagement | Melissa W.
 - Coffee talks were held every single month at both campuses (alternating between online and in person).
 - In October, Dr. Janneke Frank spoke about the Inside Out philosophy. Many requests to bring her back for additional sessions.
 - Held two different sessions with The Center of Sexuality (one for Elementary and one for Mid-High).
 - Started a new initiative called Parent Chat. Hope to bring it back next year with a few changes.
 - In May, Jill Foreman will join us on Zoom.
- d. Social Events | Lisa Fedko-Gott
 - In June 2023, we hosted the second annual year end event which was very successful (between 250-300 attendees). Planning this year's event for June 7th and still seeking volunteers. Thank you to all parents who help make this event a success!
